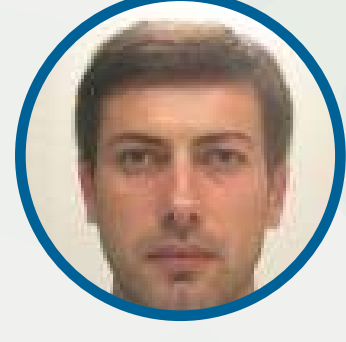


# INCOMPLETE ASSET DECLARATIONS BY PUBLIC OFFICIALS IN TSAGERI AND LENTEKHI

Transparency International Georgia studied the asset declarations of up to 45 officials in Tsageri and Lentekhi municipalities' City Halls and City Councils, and found that 15 had incomplete declarations.

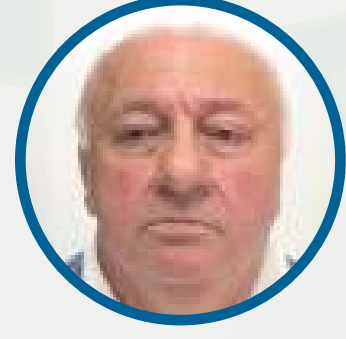
It should be noted that according to Article 18 of the Law on Conflict of Interest and Corruption in Public Institutions, if an official does not indicate an enterprise that has not had turnover in the last 6 years, the Civil Service Bureau will not find a violation. Transparency International Georgia lacks the ability to check whether the companies mentioned in the research had turnover or not. Accordingly, the study provides information on undeclared enterprises, and turnover verification is the prerogative of the Civil Service Bureau.

**MIKHEIL MESHVELIANI**  
*Deputy Mayor of Tsageri*

Mikheil Meshveliani's father, Tengiz Meshveliani, owns 70% of shares in [Armazi LTD](#). Mikheil Meshveliani's mother, Fatman Karseladze, owns 10% of shares in the same enterprise. Fatman Karseladze is registered as an [individual entrepreneur](#), which Mikheil Meshveliani did not indicate in his asset [declaration](#).



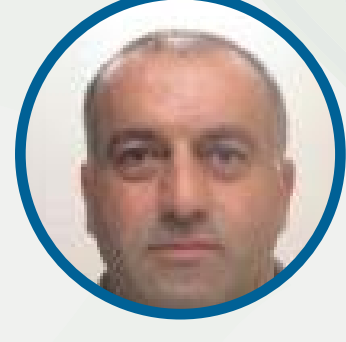
**ZURAB KHETSURIANI**  
*Head of Administrative Service at Tsageri City Hall*

Zurab Khetsuriani is registered as an [individual entrepreneur](#). His wife, Nona Beridze, is also an [individual entrepreneur](#), which, despite the requirements of the law, was not included in his declaration.



**DAVIT CHAKVETADZE**  
*Head of Health and Social Care Service at Tsageri City Hall*

Davit Chakvetadze is registered as an [individual entrepreneur](#), which he did not indicate in his 2020 declaration. Also, Davit Chakvetadze, according to the data of the Public Registry, has registered a real estate with the cadastral code since 2018: [89.03.21.032](#), which was not indicated in the 2020 declaration, despite the requirements of the law.



**GIORGI GUGAVA**  
*Chairman of Tsageri Municipality Council*

Giorgi Gugava owns 50% of shares in [Meurne LTD](#), which was not indicated in his [declaration](#) filed in 2020. Despite the requirements of the law, he did not transfer this shares with management rights to another person.



**REZO KHETSURIANI**  
*Deputy Chairman of Tsageri Municipality Council*

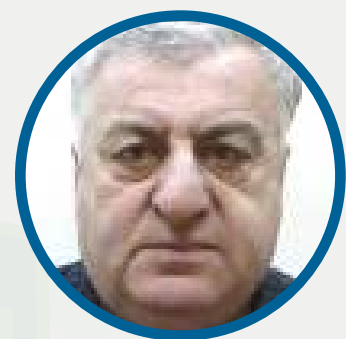
Rezo Khetsuriani owns 50% of shares in [Vitakan-Georgia LTD](#). Despite the requirements of the law, he did not indicate this information in his asset [declaration](#) and did not transfer this shares to another person with the management rights.



**MAMUKA KHABULIANI**  
*Chairman of the Spatial-Territorial Planning and Infrastructure Commission in Tsageri Council*

Mamuka Khabuliani is registered as an [individual entrepreneur](#), which he did not indicate in his asset [declaration](#).

## LENTEKHI MUNICIPALITY



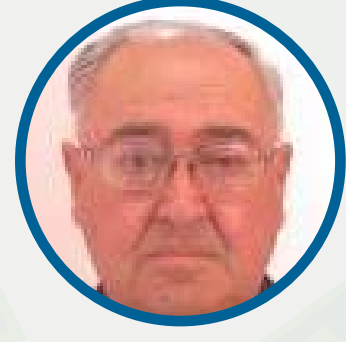
**BADRI LIPARTELIANI**  
*Mayor of Lentekhi Municipality*

Badri Liparteliani's son, Jogo Liparteliani, according to the public registry, is registered as an [individual entrepreneur](#), which, despite the requirements of law, he did not indicate in the [declaration](#).



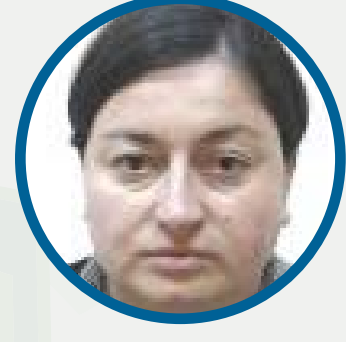
**ZURAB LIPARTELIANI**  
*Head of the Military Registration and Conscription Service of Lentekhi City Hall*

Zurab Liparteliani, according to the public registry, is registered as an [individual entrepreneur](#), which is not indicated in his property [declaration](#).



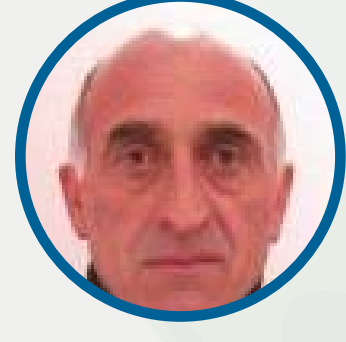
**GERMANE KURASBEDIANI**  
*Head of Internal Audit Service of Lentekhi City Hall*

Germane Kurasbediani did not indicate in his [declaration](#) that he was registered as the Director of the [Athletics Palace LTD](#), which is an incompatible activity according to the Law on Conflict of Interest and Corruption in Public Institutions.



**KHATUNA LIPARTELIANI**  
*Head of Health and Social Care Service in Lentekhi City Hall*

Khatuna Liparteliani's husband, Gocha Liparteliani, according to the Public Registry, is registered as an [individual entrepreneur](#), Khatuna Liparteliani did not indicate this in her property [declaration](#).



**AMIRAN KURASBEDIANI**  
*Chairman of the Finance-Budget Commission of Lentekhi City Council*

Amiran Kurasbediani's wife Nino Gazdeliani, according to the public registry, is registered as an [individual entrepreneur](#), which, despite the requirements of the law, Amiran Kurasbediani did not indicate in his property [declaration](#).



**IRINE LIPARTELIANI**  
*Chairman of the Mandate, Procedural Issues and Ethics Commission of Lentekhi City Council*

[Irine Liparteliani](#) and her husband, [Mirian Jankhoteli](#), are registered as individual entrepreneurs according to the Public Registry, which is not indicated in Irine Liparteliani's asset [declaration](#).



**IRAKLI KURASBEDIANI**  
*Chairman of the faction "Georgian Dream - Democratic Georgia" of Lentekhi City Council*

Irakli Kurasbediani's father, Grisha Kurasbediani, according to the Public Registry, owns 14.3% of shares in [Lentekhi Road 2000 LTD](#). Grisha Kurasbediani is also registered as an [individual entrepreneur](#), which, despite the requirements of the law, Irakli Kurasbediani did not indicate his property [declaration](#).



**MIRIANI LIPARTELIANI**  
*Deputy Chairman of the Lentekhi City Council faction "Strong Municipality"*

Mirian Liparteliani's father, Ardash Liparteliani, is registered as an [individual entrepreneur](#), which, despite the requirements of the law, Mirian Liparteliani did not indicate in his property [declaration](#).



**MAMUKA MUKBANIANI**  
*Chairman of the faction "Georgian Dream - Mretsvelebi" of Lentekhi City hall*

Mamuka Mukbanian's wife, Landa Liparteliani, according to the public registry, is registered as an [individual entrepreneur](#), which is not indicated in Mamuka Mukbanian's asset [declaration](#).

**In the fight against corruption, reviewing public officials' asset declarations is one of the most important tools. Transparency International Georgia calls upon Civil Service Bureau to study the declarations of the aforementioned public officials and respond accordingly.**
